- Set-up can begin after 10:00 AM.
- Take down at 4:00 pm. (Please note: There will be an outdoor church service on the grounds adjacent to the Mary Winspear Centre on Wednesday, beginning at 4:00pm. Out of courtesy, please try not to disrupt the service with excessive noise.)
